

YOUTH MISSION TRIP REGISTRATION

CONTRACT 2012

I would like to attend the Youth Mission Trip (MT) to Urban Mission in Steubenville, OH from June 30th to July 7th, 2012.

- I understand that the cost of the trip is \$600 per youth.
 - \$100 is a registration fee to be paid in two (2) installments of \$50 each.
 - 1st payment of \$50 is due on October 1st, 2011 along with this form and the liability release form (on reverse of this page).
 - 2nd payment is due on or before April 1st, 2012 along with the medical treatment form.
- In lieu of the remaining \$500, I agree to complete:
 - 12 hours of service time (6 hours must be at FUMC, maximum of 4 hours per event).
 - 15 hours of MT fundraisers
 - 10 hours of either MT fundraising or service time (your choice)
 - If I fail to complete these hours I will be billed for the remaining amount. This amount will be due in June upon request.

I understand that the mission trip is a yearlong commitment and will require me to make personal sacrifices to which I may not be accustomed. I will work and complete tasks to the best of my ability. I am aware that I may be asked to work hard, but I will try to preserve even though I may be tired and uncomfortable at times.

I realize that living and working together as a group will require me to display Christian love and patience toward all members of the workgroup, both youth and leaders. I realize the importance of all members of the group following a schedule and the guidance and instruction of the leaders. I am willing to comply with the requests of the leadership.

I further realize that I will be visiting an area where the culture and customs differ from those to which I am accustomed. I will treat all people at the work camp and in the community with respect as fellow Christians.

I understand that I am responsible for my actions during all fundraisers and while I am on the mission trip. I also understand that I will be held accountable for my behavior if it does not exemplify Christian behavior and purpose of the mission trip. I also understand that the use of alcohol, illegal drugs and tobacco products can result in my being sent home at my expense.

I dedicate myself to this mission, its fundraisers and to Christian service as a representative of my group and Faith United Methodist Church.

LIABILITY RELEASE AGREEMENT

WARNING THERE ARE INHERENT RISKS ASSOCIATED WITH ACTIVITIES INVOLVED IN A WORK MISSION SUCH AS FAITH UNITED METHODIST CHURCH WORK MISSION

Therefore, the participant, by signing this agreement agrees to assume the risks involved with the FAITH UNITED METHODIST CHURCH WORK MISSION. Furthermore the participant and his or her legal representative release FAITH UNITED METHODIST CHURCH, its administrators, employees, and cooperating organizations from any liability resulting from any injury, loss damage, accident, whether caused by negligence or otherwise for which the participant had applied. The participant and his or her legal representative further release FAITH UNITED METHODIST CHURCH from any liability for suggesting, including designating or identifying particular work mission projects in the event the participant suffers from any injury or harm during the work mission in which he or she participates. Without limiting the foregoing, the participant acknowledges and agrees that FAITH UNITED METHODIST CHURCH, its administrators, employees and cooperating organizations shall not be responsible for any injury, loss damage or delay resulting from;

- (1) Any act error or mission on the part of any work mission participant
- (2) Any negligence on the part of any program participants
- (3) Any defect in any equipment or vehicle engaged by any cooperating organization or the participant, or the failure of such vehicle to comply with any part of local, state, or federal rules and regulations.
- (4) Any act or neglect of any person or company whose services are obtained by any cooperating organization for the benefit of work mission participants, including but not limited to; dormitories, cafeterias, host churches, recreational sites, volunteers and transportation companies
- (5) Any deviation or delay of any kind however caused.

The above paragraph shall operate as a general release by the participant and his or her legal representative, releasing FAITH UNITED METHODIST CHURCH its administrators, employees and cooperating organization. Both the participant and his or her legal representative hereby waive any protection of, or the right to assets or local law that would modify this general release and wavier.

Submission of this agreement with a signature shall constitute an application in a work mission. This agreement shall take effect and be considered binding only upon acceptance by FAITH UNITED METHODIST CHURCH.

Having read, understood and agreed to the terms and conditions set forth above, I hereby apply to participate in a work mission conducted by FAITH UNITED METHODIST CHURCH.
